Section #4: Reasons Why you Believe the Judge's Decision should be Reviewed


I was charged with blocking a pedestrian ramp located in front of 175 Claremont Avenue in Manhattan; despite the fact parking is permitted in front of all pedestrian ramps located in the "major" street of a "T" intersection, "where the adjacent (major) street is not marked with a crosswalk and not controlled by all-way stop signs or traffic signals, even if there is a curb cut at the location." **See, NYC DOT website**.

The pedestrian ramp I was charged with blocking was such a pedestrian ramp, i.e. located in the "major" street of a "T" intersection, where the adjacent (major) street is not marked with a crosswalk and not controlled by all-way stop signs or traffic signals. It was perfectly legal to park where I was parked.

I have done a considerable amount of research on this issue. Notwithstanding the notoriety given the revised pedestrian ramp rule by the media, bloggers, and the official DOT website, these illegal parking tickets are still issued, and cars are towed. In my case, I parked legally, was issued an illegal parking ticket, and my vehicle was towed. I have attached the detailed information I provided the original judge.
