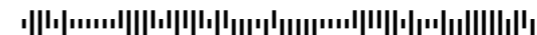

An unmarked crosswalk is that part of the roadway, other than a marked crosswalk, which is included within the extensions of the sidewalk lines between opposite sides of the roadway at an intersection, provided that (A) the roadway crosses through the intersection rather than ending at the intersection, and/or (B) all traffic on the opposing roadway is controlled by a traffic control device.

The Respondent denies they were in the cited zone and submits photographs and google images. This is not a persuasive defense because the google images and photographs do not show the vehicle or how it was parked in relation to the crosswalk zone. As such, they fail to show that no portion of the vehicle extended over the roadway lines or into the cited zone. Guilty. D
